NOTIFICATION

BOMBAY PROVINCIAL MUNICIPAL CORPORATION ACT, 1949.

No. LBT. 2011/CR-88/UD-34.—Whereas, by the Government Notification, Urban Development Department, No. LBT-2011/CR-22/11/UD-34(2), dated the 18th February 2011 issued in exercise of the powers conferred by the section 99B read with section 152P and 152Q of the Bombay Provincial Municipal Corporation Act, 1949 (Bom. LIX of 1949), the Government of Maharashtra has directed that the rates at which the Local Body Tax shall be levied on entry of various categories of goods into the limits of the City by the Municipal Corporation of the City of Solapur for consumption, use or sale therein, in the official year commencing from the 1st April 2011, shall be such as are specified in Schedule-A appended to the said notification; and has also directed that no Local Body Tax shall be levied by the said Corporation on the entry of various categories of goods specified in Schedule-B appended thereto;

And whereas, the Government of Maharashtra, after considering the proposal of the Commissioner of the Municipal Corporation of the city of Solapur, in order to improve the acceptability of the Local Body Tax and to ensure better tax compliance, considers it expedient to revise the rates of Local Body Tax on entry of various categories of goods into the limits of the City for consumption, use or sale therein, determined under section 99B *vide* the said notification;

Now, therefore, in exercise of the powers conferred by section 99D read with sections 152P and 152Q thereof, of the Bombay Provincial Municipal Corporations Act, 1949 (Bom. LIX of 1949), and of all other powers enabling it in that behalf, and in supersessions of Government Notification, Urban Development Department No. LBT 2011/CR-22/11/UD-34 (2) dated the 18th February 2011, the Government of Maharashtra hereby directs that with effect from 1st September 2011—

(a) the rates and the extent to which the Local Body Tax shall be levied by the Municipal Corporation of the City of Solapur on entry of various categories of goods into the limits of the city for consumption, use or sale therein, shall be such as are specified in Schedule-A appended hereto; and

(b) no Local Body Tax shall be levied by the Municipal Corporation of the City of Solapur on the entry of various categories of goods into the limits of the City for consumption, use or sale therein, as are specified in Schedule-B appended hereto.
